OVERSEAS REGULATORY ANNOUNCEMENT ANNOUNCEMENT ON OPERATING DATA FOR NOVEMBER 2023

This overseas regulatory announcement is made pursuant to Rule 13.09 and Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

China Eastern Airlines Corporation Limited (the “**Company**”) and all members of the board of directors confirm that the information contained in this announcement is true, accurate and complete, and no misrepresentations, misleading statements or material omissions are contained herein.

I. OPERATIONS

In November 2023, the Company’s passenger transportation capacity (measured by available seat kilometres) increased by 271.05% year-on-year; passenger traffic volume (measured by revenue passenger kilometres) increased by 334.52% year-on-year; passenger load factor increased by 11.13 percentage points year-on-year to 76.18%. In November 2023, freight traffic volume (measured by revenue freight tonne-kilometres) increased by 10.49% year-on-year.

In November 2023, the launch of new routes, resumption of routes and increased flight frequency of routes for domestic, international and regional markets of the Company are as follows:

Domestic market: New routes such as Changchun — Huai’an — Guilin, Changchun — Nanchang — Qionghai, Nanchang — Huai’an — Taiyuan; resumed route of Qingdao — Yibin — Kunming; and increased flight frequency for routes such as Shanghai Hongqiao — Tianjin, Shanghai Hongqiao — Nanning, Ningbo — Wuhan, Xi’an — Haikou, Xi’an — Shenzhen, Xi’an — Sanya.

International market: New routes such as Hangzhou — Sydney — Auckland, Jinan — Sydney, Wenzhou — Madrid, Nanjing — Singapore; resumed routes such as Shenzhen — Bangkok, Lanzhou — Bangkok; and increased flight frequency for routes such as Shanghai Pudong — Los Angeles, Shanghai Pudong — Paris, Shanghai Pudong — London Gatwick, Shanghai Pudong — Sydney, Shanghai Pudong — Melbourne, Shanghai Pudong — Tokyo Haneda, Shanghai Pudong — Tokyo Narita, Shanghai Pudong — Osaka, Shanghai Pudong — Hanoi, Kunming — Bangkok, Kunming — Chiang Mai.

Regional markets: Increased flight frequency for routes such as Shanghai Pudong — Hong Kong, Wuxi — Hong Kong, Kunming — Hong Kong.

II. FLEET STRUCTURE

In November 2023, the Company did not introduce any aircraft and retired two aircraft. As of the end of November 2023, the Company operated a total of 780 aircraft, including 296 self-owned aircraft, 258 aircraft under finance lease and 226 aircraft under operating lease.
