OVERSEAS REGULATORY ANNOUNCEMENT ANNOUNCEMENT ON OPERATING DATA FOR SEPTEMBER 2024

This overseas regulatory announcement is made pursuant to Rule 13.09 and Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

China Eastern Airlines Corporation Limited (the “**Company**”) and all members of the board of directors confirm that the information contained in this announcement is true, accurate and complete, and no misrepresentations, misleading statements or material omissions are contained herein.

I. OPERATIONS

In September 2024, the Company’s passenger transportation capacity (measured by available seat-kilometres) increased by 10.33% year-on-year, reaching 107.82% of the same period of 2019; passenger traffic volume (measured by revenue passenger-kilometres) increased by 25.17% year-on-year, reaching 112.75% of the same period in 2019; passenger load factor increased by 9.90 percentage points year-on-year to 83.51%, representing an increase of 3.65 percentage points as compared with that of the same period of 2019. In September 2024, freight traffic volume (measured by revenue freight tonne-kilometres) increased by 12.79% year-on-year, reaching 110.11% of the same period in 2019.

For domestic market, in September, the Company launched new routes such as Ningbo — Datong, Nanjing — Mangshi, increased flight frequency for routes such as Shanghai Hongqiao — Beijing Daxing, Shanghai Pudong — Dunhuang, Shanghai Pudong — Tianjin, Beijing Daxing — Harbin, Beijing Daxing — Chengdu Shuangliu, Chengdu Tianfu — Qingdao, Guangzhou — Wenzhou. In September, the Company's passenger transportation capacity in the domestic market reached 113.59% of the same period in 2019.

For international market, in September, the Company newly launched routes such as Shanghai Pudong — Venice, Shanghai Pudong — Kazan Airport, Xi'an — Milan, resumed routes such as Yantai — Bangkok, and increased flight frequency for routes such as Shanghai Pudong — Sydney, Beijing Daxing — Kuala Lumpur, Kunming — Yangon. In September, the Company's passenger transportation capacity in the international market has recovered to 97.22% of the same period in 2019.

For regional market, in September, the Company's passenger transportation capacity in the regional market has reached 109.79% of the same period in 2019.

II. FLEET STRUCTURE

In September 2024, the Company introduced three aircraft, including one B737 series aircraft, one A320 series aircraft and one C919, with two A320 series aircraft retired. As of the end of September 2024, the Company operated a total of 790 aircraft, including 341 self-owned aircraft, 232 aircraft under finance lease and 217 aircraft under operating lease.

Notes:

1. Available tonne-kilometres (ATK) means the sum of capacity available for the carriage multiplied by the distance flown for every route.
2. Available seat-kilometres (ASK) means the sum of the maximum number of seats made available for sale multiplied by the distance flown for every route.
3. Available freight tonne-kilometres (AFTK) means the sum of the maximum tonnes of capacity available for the carriage of cargo and mail multiplied by the distance flown for every route.
4. Revenue tonne-kilometres (RTK) means the sum of load (passenger and cargo) in tonnes multiplied by the distance flown for every route.

5. Revenue passenger-kilometres (RPK) means the sum of the number of passengers carried multiplied by the distance flown for every route.
6. Revenue freight tonne-kilometres (RFTK) means the sum of cargo and mail load in tonnes multiplied by the distance flown for every route.
7. Weight of freight carried means the actual weight of freight carried.
8. Overall load factor means the ratio of traffic revenue tonne-kilometres to ATK.
9. Passenger load factor means the ratio of RPK to ASK.
10. Freight load factor means the ratio of RFTK to AFTK.
11. Freight transportation data only contained data of passenger aircraft bellyhold space and Passenger-to-Cargo Conversion. The table does not contain data of the fleet of all-cargo aircraft.
